SURFBOARD RENTAL AGREEMENT & DAMAGE POLICY

This Surfboard Rental Agreement (“Agreement”) is entered into between:

Wanted Board Rentals, Estrada do Guincho, Cascais, Portugal (hereinafter referred to as “Company”)

3. Condition of Equipment

The Customer confirms that the surfboard and accessories were received in good working condition unless otherwise noted above. All equipment must be returned clean and in the same condition, excluding normal wear from proper surfing use.

4. Damage Policy

The Customer accepts full financial responsibility for the surfboard during the rental period. Unless covered by our damage cover in which all terms are underlined in our damage policy document agreed to when making the initial reservation.

- Small ding (up to 10cm): €35
- Medium ding (10–20cm): €50
- Large ding (20cm+ or multiple impacts): €70
- Broken leash: €20
- Single broken fin: €25 (per fin)
- Fin box repair: €50
- Snapped board (repairable): €100 – €120
- Board beyond repair / total loss: the agreed replacement value stated in the rental agreement

Damage assessment and severity determination are at the sole discretion of Wanted Board Rentals and/or its authorized repair partner.



5. Loss or Theft

In case of loss or theft, the Customer is fully responsible for paying the agreed board value stated above.

6. Use of Equipment

The Customer agrees:

- To use the equipment only for surfing.
- Not to lend, sub-rent, or transfer the board to another person.
- To use the board only in conditions suitable to their skill level.
- Not to surf in dangerous or prohibited areas.
- Not to intentionally damage or misuse the equipment.

The Customer confirms they are physically capable of surfing.

7. Liability Waiver

Surfing is an inherently risky activity. The Customer acknowledges and accepts all risks associated with surfing, including injury, collision, impact with seabed, equipment failure, and weather conditions.

Wanted Board Rentals assumes no responsibility or liability for any injury, accident, death, loss of property, or damage caused to third parties.

The Customer releases and holds harmless Wanted Board Rentals, its owners, employees, and partners from any claims arising from use of the equipment.

8. Late Returns

Late returns may be charged at an additional full rental day rate.

9. Cancellation & Refund Policy

No refunds will be given for early return of equipment.

10. Jurisdiction

This Agreement is governed by the laws of Portugal. Any disputes shall be resolved under Portuguese jurisdiction.
